## UC BERKELEY STARTUPS BY THE NUMBERS

- More than **800** startups have been founded on UC patents — and over **600** are active or have had a successful exit
- **186** Startups have formed around UC Berkeley technology since 1980
- **29** Startups have gone on to have a successful exit via merger or acquisition
- Acquisition terms for UC Berkeley startups have totaled at least **\$8.1B** in cash and stock options
