The Office of Intellectual Property and Industry Research Alliances (IPIRA) has the mission of enhancing the research enterprise of the Berkeley campus by establishing multifaceted collaborations and corresponding agreements with companies. These activities include sponsored research collaborations and intellectual property licensing. IPIRA reports to the Vice Chancellor for Research and consists of two peer divisions: the Office of Technology Licensing (OTL), and the Industry Alliances Office (IAO).

Berkeley is ranked as one of the top 5 universities for industry collaborations.

**IPIRA** has negotiated agreements with over 1,300 industry partners since 2004.

**IPIRA** has helped researchers secure over \$1B in research funding.

IPIRA has brought in over \$260M in IP licensing revenue to Berkeley. Over \$60M was distributed to inventors and authors.

Companies with IP licenses from IPIRA have commercialized well over 600 products and services - and hundreds more are in R&D pipelines.

Over 217 startup companies were founded to commercialize inventions and copyrights under licenses from IPIRA.


In 2015, 66 of Berkeley's startups employ 1,543 Californians and generate \$195M in annual revenue.

Between 2005-2013, Berkeley startups have attracted \$1.6B in venture funding.

#### Berkeley's Industry-Sponsored Research Budget



In FY2018 IPIRA's Industry Alliances Office (IAO) assisted researchers from 10 of Berkeley's 14 schools and departments to secure \$77M in Industry-Sponsored Research funding.

In FY2018 the IAO has also supported faculty research by executing numerous membership agreements for Berkeley's 17 Industry Affiliate Programs.

The IAO further supports research endeavors by negotiating 900+ agreements annually including research agreements, incoming material, data agreements, and confidentiality agreements.

## **Startup Resources**

In its role of establishing license and research agreements with companies, IPIRA is inherently a core resource of Berkeley's vast innovation and entrepreneurship ecosystem.

The Industry Alliances Office (IAO) supports researchers who are collaborating with small companies by helping them apply for SBIR grants. Contact the IAO if you have questions about applying or contracting for these grants.

In collaboration with the NSF I-CORPS Program, IPIRA has launched an NSF SBIR workshop that helps startups increase the liklihood that companies will successfully draft grants to obtain NSF SBIR funds. Contact IPIRA if you want to participate in these workshops because they fill quickly.

To help entrepreneurs become familiar with the licensing process, IPIRA also provides template licensing agreements.

# Office of Technology Licensing

In FY 2018 IPIRA's Office of Technology Licensing:

- Grossed over \$18M in IP licensing revenue and legal reimbursements.
- Obtained 92 US Patents and 125 foreign patents.
- Evaluated 216 invention disclosures from 11 of Berkeley's 14 colleges and schools.
- Filed 185 U.S. and 33 foreign patents (excluding PCTs).
- Licensed IP rights to 15 new startup companies that were founded to commercialize inventions and software from Berkeley.
